Deer Management Pilot Overview

Purpose	City of Pittsburgh Deer Management Pilot Program			
Approval Timeframe	Deer Management Pilot Program Legislation approved by Pittsburgh City Council September 6, 2023, in cooperation with the USDA APHIS Wildlife Services Team.			
Program Scope	The City of Pittsburgh's Deer Management Pilot Program was enacted for Frick and Riverview Parks to assist with the overabundance of deer. The program lasted from 9/30-12/9 and 12/26-1/27 excluding all Sundays.			
Management Plan	The overabundance of deer in Pittsburgh has historically gone unchecked and unmanaged. With increasing reports of deer over browsing, vehicle-deer collisions, and loss of natural fear, the urgency to enact a management plan was essential.			

Timeline: Then and Now

A timeline was established during the pilot phase of the city's Deer Management Program to ensure a seamless implementation. Adhering to the dates set forth made it possible for all tasks to be completed in 2023. Therefore, the designed schedule should be adopted to ensure all tasks and responsibilities of the City are completed. This does not include community outreach opportunities or additional engagement with internal city departments.

Pilot Phase Dates

Jan - Mar 2023: External Protect your Parks & Gardens Community Group formulated and connection with the City of Pittsburgh Park Rangers.

March 2023: Early conversations with USDA APHIS WS team

June 2023: Conversations and early proposals to Pittsburgh City Council Began

September 6, 2023: Passed by Pittsburgh City Council

September 7, 2023: Archers selected from lottery

September 10, 2023: Archer Accuracy Examination 1

September 21, 2023: Archer Accuracy Examination 2

Sept 30 - Dec 9, 2023: Archery Season One Begins 80 deer harvested | 47 deer donated (1,920 lbs venison, 7,680 meals)

Dec 26, 2023 - Jan 27, 2024: Archery Restarts *Finals Harvest Results: 108 deer harvested, 59 donated* (2,360 lbs venison, 9,440 meals)

January 18, 2024: City Park Rangers Debrief with USDA Wildlife Technicians Brian & Thomas

March 20, 2024: "Posted: No Hunting" signs created for posting in Schenley, Emerald View & Highland Parks

March 26, 2024: Hunting Zones created & revised for five Allegheny Regional Asset District (ARAD) Parks (Frick, Riverview, Schenley, Emerald View & Highland Parks).

Schedule Moving Forward

April 2024: USDA Contract to be approved and first dues paid

April 2024: Schenley Park to be posted with 30 "Posted: No Hunting" signs

April 2, 2024: Debrief with Community Stakeholders & Mayors Office

May 2024: Emerald View Park to be posted with 30 "Posted: No Hunting" signs

May 1, 2024: Announce Lottery Sign Ups starting 5/13

May 13, 2024: Open Sign-Ups for Lottery System (two weeks)

June 3, 2024: Select Archers from Lottery

June 2024: Highland Park to be posted with 30 "Posted: No Hunting" signs

July 2024: 125 "Notice of Archery Signs" to designed and printed on plastic.

July 14, 2024: First Archery Qualifier

July 24, 2024: Secondary Archery Qualifier

August 2024: 25 "Notice of Archery Signs" to be posted in each ARAD Park.

September 2024: Archery to begin

Strengths

- 1. **Managing the deer overabundance** in a sustainable, controlled manner with authorized, vetted, accurate archers.
- 2. Allowing residents of Pittsburgh to hunt in their local park with **an opportunity to harvest their own food.**
- 3. Providing 9,440 meals for those suffering from food insecurities from donated venison.
- 4. The Post Archery Program Completion Survey provided great feedback with positive remarks. 100% of survey participants would be interested in returning.
- 5. Resident Benefits:
 - a. Reduced risk of vehicle-deer collisions
 - b. Increase fear of humans
 - c. Reduced risk of tick-borne illness
- 6. Ecosystem benefits from deer management piloted parks:
 - a. Greater increase in plant regeneration resulting in a healthier understory, reduced storm water run-off, and increase in food sources for deer.
 - b. Reduction of deer that could suffer or spread Chronic Wasting Disease or Hemorrhagic Disease.

Improvements

- 1. Minor adjustments and requirements of **onboarding archers to include an age minimum of 18 years old** and no enrollment in other deer management programs.
- 2. Minor adjustments to the rules of the program to include:
 - a. A formal substitution policy for archers that can no longer participate including for reasons such as injury, time constraints, and/or out of tags.
 - b. Require all participants to label arrows in addition to their tree stands and game camera with their identification number.
 - c. Recommend all archers hunt with a tarp to assist with removal of the deer to prevent public upset.
 - d.d.Decrease number of archers per park to ten archers.
- 3. Install one field dressing station that archers in the program can utilize during the program.
- 4. Simplify the post-hunt summary and require all archers to submit reports within 24 hours.
- 5. Evaluate options for local butchering which would lessen the time allotment needed to donate their harvest.
- 6. Hunting from the ground was requested for archer safety and concerns of tree stands being stolen.
- 7. The City of Pittsburgh Deer Management Plan is still limited to large parks and greenways excluded in 2024-2025 plans including Hays Park.
- 8. Expand the EngagePGH page with updated information and more resources about archery in urban environments.
