Breakout Group 1 – Josiah (main room)

1. **Public Safety**

Encourage community health & safety within a community through supportive tactics which foster safe spaces, and engagements with law enforcement that improve trust and community well-being.

2. **Public Facilities & Services**

Recreational spaces that are appealing to and meet the needs of Oakland residents and visitors, as well as collaborative public and institutional facilities becoming spaces of community gathering and public usage.

3. **Public Health**

Oakland is a place that is healthy for the body, where all partners (both individuals and institutions) prioritize Oakland's public health efforts in the context of social determinants of health, especially as it relates to access to affordable housing, clean air & water, quality food, childcare, and healthcare.

4. **Community Uses In The Right-of-way**

Oakland's residents and institutions can use the right-of-way in innovative and beneficial ways.



Breakout Group 2 -- Alyssa

1. **Community Programs & Livability**

Community programs improve in quality and in their ability to directly meet the needs of Oakland's families and children with an emphasis on the most vulnerable populations.

2. **Cultural Heritage & Preservation**

Prioritize longevity and continuity of a community as well as its architecture and cultural relevancy when evaluating cultural heritage & preservation processes.

3. **Public Art**

Opportunity to acknowledge, maintain, and highlight the extraordinary contributions of diverse artists and artistic disciplines that make up the fabric of public art in Oakland while intentionally engaging with diverse contemporary artists and co-empowering them and the community to lift additional voices and identities.

4. **Nuisance & Enforcement Issues**

Policy and practice around nuisance and enforcement support community well-being and healthy living through enforcement and application; while combatting displacement and gentrification by connecting need-based resources to residents.

5. **Schools & Related Programs**

Oakland is a place where the developing needs of every resident can be met through public and private options for neighborhood schooling and learning.
